Sostravel.com: has obtained the status of Innovative PMI (Innovative Small-Medium-Sized Enterprise)

Milan-2 August 2018 – SosTravel.com S.p.A. (AIM Italia, ticker: SOS) , digital operator in the market of air transport passenger assistance services announced that yesterday it obtained the status of PMI INNOVATIVA (INNOVATIVE SMALL-MEDIUM-SIZED ENTERPRISE) from the Varese Chamber of Commerce, recognizing the company's propensity towards technological innovation in the development of its own business model.

The Stability Law of 2017 introduced two facilities which, due to the fact that they can be combined, make the investment in Innovative PMIs listed on AIM Italia more attractive:

- tax relief for professional and retail investors (both for investments made via capital
 increase and via exercising Warrants and convertible bonds): individuals may deduct
 from their taxes 30% of the amount invested, while companies may deduct 30% from
 their taxable income, as well as benefiting from the exemption from capital gains if
 shares are placed in a PIR (Individual Savings Plan);
- maximum benefit: the maximum investment on which the deduction can be calculated rises from 500 thousand Euros to 1 million Euros (for subjects liable for IRES taxation the maximum investment in each tax period remains 1.8 million Euros).

Note that the discipline for Innovative PMIs has not yet been applied in a tangible manner, since the relevant authorities have not yet issued any implementation decrees.
