### **Sostravel: Communication about change in Share Capital**

Milan, 19 September 2019. **Sostravel.com S.p.A.**, digital operator in the air passenger assistance services market listed on the Italian Stock Exchange – AIM Italia segment (ticker: SOS), communicates that the certification of the increase in share capital announced in the press releases issued on 11 September 2019 and 17 September 2019, was lodged and registered with the Companies Register of Varese on 17 September 2019 and that the relative paperwork was completed yesterday, 18 September 2019.

These communications refer to the operation involving the assignment of 47,225 Bonus Shares to each participant in the IPO who will have retained the Issuer's shares without interruption for at least 12 months from the date on which the negotiations commenced.

Due to the above-mentioned capital increase, the free float increased from 47.51% in 12 August 2019 to the current rate of 47.93%.
