Sostravel signs a distribution agreement for the sale of the “Dr. Travel” telemedicine service on the TraWell network

Milan, 1 March 2021. **Sostravel.com S.p.A.**, listed on the Italian Stock Exchange – AIM Italia (ticker: SOS) segment, digital operator in air passenger assistance services, announces, as already mentioned in the press release of 2 November last year, that today it has signed a distribution agreement for the sale of the “Dr. Travel” telemedicine service on the TraWell network.

The Dr. Travel service provides medical assistance to travellers suffering from general health problems during their journey (around 1 out of every 3 travellers) and which, very often, are not covered by most medical insurances (which basically manage serious pathologies – heart attacks, strokes, fractures, etc.- around 4% of cases, leaving the remaining 96% uncovered). The multi-lingual Dr. Travel service will be available via the sostravel APP, directly from the traveller's own smartphone and will give 14-day coverage from the departure date.

The TraWell Group operates through around 160 points of sale, in 52 airports and 16 countries. Pre-covid, sostravel developed on the TraWell network around 2 million euros of sales on the Lost&Found Concierge service alone.

We also announce that today Managing Director Dr. Luca Galea handed in his resignation to the Chairman Dr. Gentile, due to work commitments.

Therefore, starting from today, the new Board of Directors will be composed of:

- o Rudolph Gentile: Chairman of the Board of Directors and Managing Director;
- o Simone Gamba, board member without delegation;
- o Nicola De Biase, board member without delegation;
- o Edoardo Zarghetta: independent board member (with independence requisites pursuant to art. 148, subsection 3 of the TUF (Unified Finance Law)).
