Sostravel: communication of change in share capital Milan

Milan, 5 September 2022 – SosTravel.com S.p.A. (Euronext Growth Milan, ticker: SOS), digital operator of the assistance services market for air transport passengers ("SosTravel" or the "Company"), communicates the new composition of the share capital following the filing with the Register of Varese companies of the certification of the capital increase pursuant to art. 2444, paragraph 1, of the Italian Civil Code civ., carried out today following the exercise of the Sostravel Warrants 2021-2024 - ISIN IT0005446718 - (hereinafter also the "Sostravel Warrant") until 31 August 2022. The deposit was therefore carried out with 1 working day of delay compared to what was communicated on 1st September.

The change in the share capital occurred following the issue of no. 280 Sostravel ordinary shares (ISIN IT0005338675), with no par value, resulting from the exercise of no. 280 Sostravel Warrants occurred during the month of August.
