# AGREEMENT WITH COSTA CROCIERE TO SELL LOST LUGGAGE CONCIERGE SERVICE

On the economic-financial level, SosTravel expects that the agreement will lead to a 50% increase in revenue for the "traveler services" business unit in 2024, compared to the figure of 734,794 euros contained in the annual report as of 12-31-22.

On the cost side, an investment of less than 110,000 euros is expected to develop software applications for the tracking and dynamic return of luggage and expand customer care.
