

NOTICE OF CHANGE IN MAJOR SHAREHOLDERS

Rome, 1 July 2026 – **sostravel.com S.p.A.** (Euronext Growth Milan, ticker: SOS), a travel tech operator offering digital services for bookings, itineraries and proprietary services that simplify the travel experience via the Sostravel and Flio apps and the platforms www.sostravel.com and www.amare.travel (“**Sostravel**” or the “**Company**”), announces that on 29 June 2026 it received: (i) a notification from Carmine Colella regarding a material change in his shareholding following the contribution of 2,659,532 ordinary shares in Ananta Holding S.r.l. (“**Ananta Holding**”) upon the incorporation of the latter (the “**Contribution**”); and (ii) a notification from Ananta Holding regarding a material change in its shareholding following the Contribution.

The aforementioned notifications result in a material change in the significant shareholders, as the materiality thresholds have been exceeded, both upwards and downwards. In particular, the voting rights held by Carmine Colella, which prior to the Contribution amounted to 20.18% of the share capital, stood at 0% on the date of notification of the material change. As a result of the Contribution, the voting rights held by Ananta Holding, which originally amounted to 0% of the share capital, now stand at 20.18% as at the date of notification of the material change.

It should be noted that the transfer took place at the book values of the shareholding held by Carmine Colella in Sostravel and that, following the completion of the transfer, Ananta Holding will be wholly owned by Carmine Colella.

On the basis of the notifications received from shareholders and the information currently available to the Company, the new composition of Sostravel’s share capital is therefore as follows:
